Global Ecolabelling Network (GEN) Enhances Capacity with New Vice Chair Appointments and welcomes an Experienced Leader as new Director, Adds new EU Secretariat

The Global Ecolabelling Network (GEN) today announced a strategic enhancement of its leadership structure with the appointment of two Vice Chairs to strengthen its organizational capacity and global reach, alongside the addition of a new Director.

- Represent GEN at critical international fora
- Coordinate external communication strategy with partners

Under her leadership since 2018, the Nordic Swan Ecolabel has become the second most valued brand in Finland. Her role on the Nordic Swan Ecolabelling board of directors further strengthens GEN's connections with leading regional ecolabelling programs.



"The creation of these focused roles reflects our commitment to strengthening GEN's organizational capacity rather than changing our power structure," Venkatagiri emphasized. "All strategic decisions will continue to be made collectively by the Board, with these Vice Chair roles serving to improve our operational execution and responsiveness."



# **Additional Secretariat Joins at Heart of EU**

Following last year's successful establishment of the Americas Secretariat based in Brazil, we also welcome the appointment of a 2nd regional Secretariat with an EU Secretariat based in Brussels. Commencing in February the new role will be embedded at the heart of the European Union supporting both our regional members needs and the global members engagement with key European markets and policymakers. A formal announcement will follow in February.



These appointments come at a crucial time as environmental certification and ecolabelling play an increasingly vital role in driving sustainable consumption, sustainable public procurement and production patterns worldwide. The new structure will enable GEN to be more responsive to both member needs and external opportunities. Enhanced Asian and more European representation reflects the consumer, business and government prioritisation in these regions towards high integrity ecolabels.
