

SEC'S ENHANCED SINGAPORE GREEN LABELLING SCHEME IS FIRST TO RECEIVE ISO/ IEC 17065 ACCREDITATION FOR CERTIFYING GREEN PRODUCTS

Singapore, 7 May 2019: The Singapore Environment Council's (SEC) has been awarded ISO/IEC 17065 accreditation for its enhanced Singapore Labelling Scheme (SGLS) certification under pulp and paper category, the first NGO certifying body to receive the accreditation.

SEC pioneered the enhanced SGLS. The ISO/ IEC 17065 accreditation is further validation that SEC's enhanced SGLS processes are based on impartial, independent, sound, reliable risk management profiling. This ensures that corporate governance at Board and management levels are owned.

The accreditation process has seen SEC's certification procedures and operating processes audited against the highest international standards that certification programmes can be exposed to. With the ISO 17065 accreditation, SEC's enhanced SGLS now has the distinction of being the first such certification in the world to receive this accolade.

The enhanced SGLS uses a comprehensive risk management profiling to complement its more extensive qualification criteria, especially in fire management and peatland management. This enables SEC to provide full risk management profiling to systematically review practices and enable surveillance over the entire supply chain management of the pulp and paper applicants, which includes plantations, mills, secondary mills, products and distributors.

Ms Jen Teo, Executive Director, Singapore Environment Council, said: "The ISO/IEC 17065 accreditation is another international milestone for SEC as the enhanced SGLS validates and upholds standards in accordance with international accreditation. Overall, SEC's Green Labelling Scheme is a globally recognised certification already under the Global Ecolabelling Network. Once the product is green labelled, it is recognised in over 40 countries.



"SEC has also applied for the International Social and Environmental Accreditation and Labelling Alliance (ISEAL) accreditation this year, and it will be the next milestone to validate our good practices and endorse SEC's open, rigorous and accessible certification system. It validates especially the surveillance of social aspects of businesses."

The enhanced SGLS for pulp and paper category was launched in January 2017 in response to the absence of peatland management and fire management in this category. Along with the enhanced criteria, a risk management profiling is adopted in assessing companies' practices and standards. Companies that do not keep within the guidelines and requirements may have its certification temporarily restricted or revoked.

Eight global companies from various countries have been certified under the enhanced SGLS. They have demonstrated a commitment to transparency in their supply chains, as well as meeting high standards of sustainable forestry which includes adopting good peatland management and committing to investments and processes for the early detection and suppression of fires when they occur.

Another five companies have submitted applications for pulp and paper products and are currently undergoing the enhanced SGLS evaluation process, in addition to other companies outside Singapore which have also made enquiries on SEC's Green Label certification.

The tougher green labelling scheme incorporates internationally recognised best practices in creating the criteria. SEC's Green Label certification incorporates relevant International Organization for Standardization environmental management standards, forestry standards such as those equivalent to Forest Stewardship Council (FSC), fire management standards from Occupational Health and Safety Assessment Series 18001 (OHSAS 18001) and peatland management to address pertinent issues relating to planting on peatland.

"We believe our set of criteria for enhanced SGLS for pulp and paper category is already amongst the most stringent in the world. It is benchmarked against other countries with tough environmental labelling standards, such as the European Union (EU), Australia, New Zealand and Japan, and uses a risk-based evaluation system to complement its more

extensive qualification criteria," said Liow Chean Siang, Head, Environmental Certifications, Singapore Environment Council.

Singapore Environment Council is the only eco-labelling body in Singapore that is a member of the Global Eco-labelling Network (GEN) whose mandate since inception in 1994 is to improve, promote, and develop the eco-labelling of products and services. Only environmentally friendly products and services proven to have lower environmental impact may carry a GEN member ecolabel.

To date, SEC has achieved several accreditations from internationally recognised standards bodies. In 2017 its SGLS was successfully audited by the Global Eco-labelling Network, meeting ISO 14024 standards for the GENICES accreditation. In 2018, SEC was awarded accreditation to the United Nations Environment Programme (UN Environment) and became Singapore's first environmental non-government organisation to achieve the accolade. In September 2018, SEC had received the ISO/ IEC 17065 accreditation earlier for paints and coatings due to the high level of corporate governance it administers in assessing and certifying the products thus setting the foundation for the scope for pulp and paper products.

Singapore Environment Council's SGLS certification began in 1992 and endorses industrial and consumer products that are produced in an environmentally-friendly manner across a range of categories, from office machines to detergents, hygiene products, packaging to paints, surface coatings and building products.

SEC has eco-certified 3,800 products from 770 international and local companies, marketed in over 40 countries including Malaysia, Indonesia, China and the United States.

Singapore Environment Council, through its three key pillars namely awards and accolades, eco-label certification programmes and training and education, recognises environmental stewardship among corporates, students and journalists, and educate and empower them to take action on sustainability and waste management.
