



## More companies coming forward to declare their procurement of wood, paper and/or pulp materials are from sustainable sources

**Singapore, 12 October 2015** –The Singapore Environment Council (SEC) and Consumers Association of Singapore (CASE) have reached out to more than 3,000 companies to get their commitment and declaration that they procure their wood, paper and/or pulp materials from sustainable sources. These include bookstores, retailers and manufacturers. More are expected to submit their declarations in the coming days.

CASE would like to strongly urge consumers to review the list and not support companies who have behaved irresponsibly and contributed to the haze problem. Individual consumers can show their opposition to their activities by not purchasing products sold from these companies. This will apply greater economic pressure on these companies to behave environmentally responsible in the long run. While a purchase decision is an individual consumer act, it becomes much more powerful if all consumers are willing to work together in this.

SEC and CASE are also reaching out to printing companies as well as manufacturers and distributors of recycled materials including wood-related products to encourage them to come forward to declare that they have not procured or used wood, paper and/or pulp materials from the six companies named by the NEA accused of causing fires in Indonesia. This is an on-going effort to engage with key stakeholders from the relevant industries to commit them to responsible 'green procuring'. To-date, 38 companies have signed the declaration (please refer to Annex B). The list of companies which have signed the declaration forms will also be updated on both the SEC-SGLS's (<http://www.sgls.sec.org.sg/>) and CASE's (<https://www.case.org.sg/>) websites.

The process by which stakeholders check and declare that their wood, paper and/or pulp materials are procured from sustainable sources can be best understood with reference to the timber, paper and pulp supply chain chart in Annex A. SEC's Green Labelling Scheme have an additional 210 companies aside from Paper related products that are part of the timber, paper and pulp supply chains in the picture shown in Annex A. Consumers are advised to choose wood products carefully and look for the Green Label too.

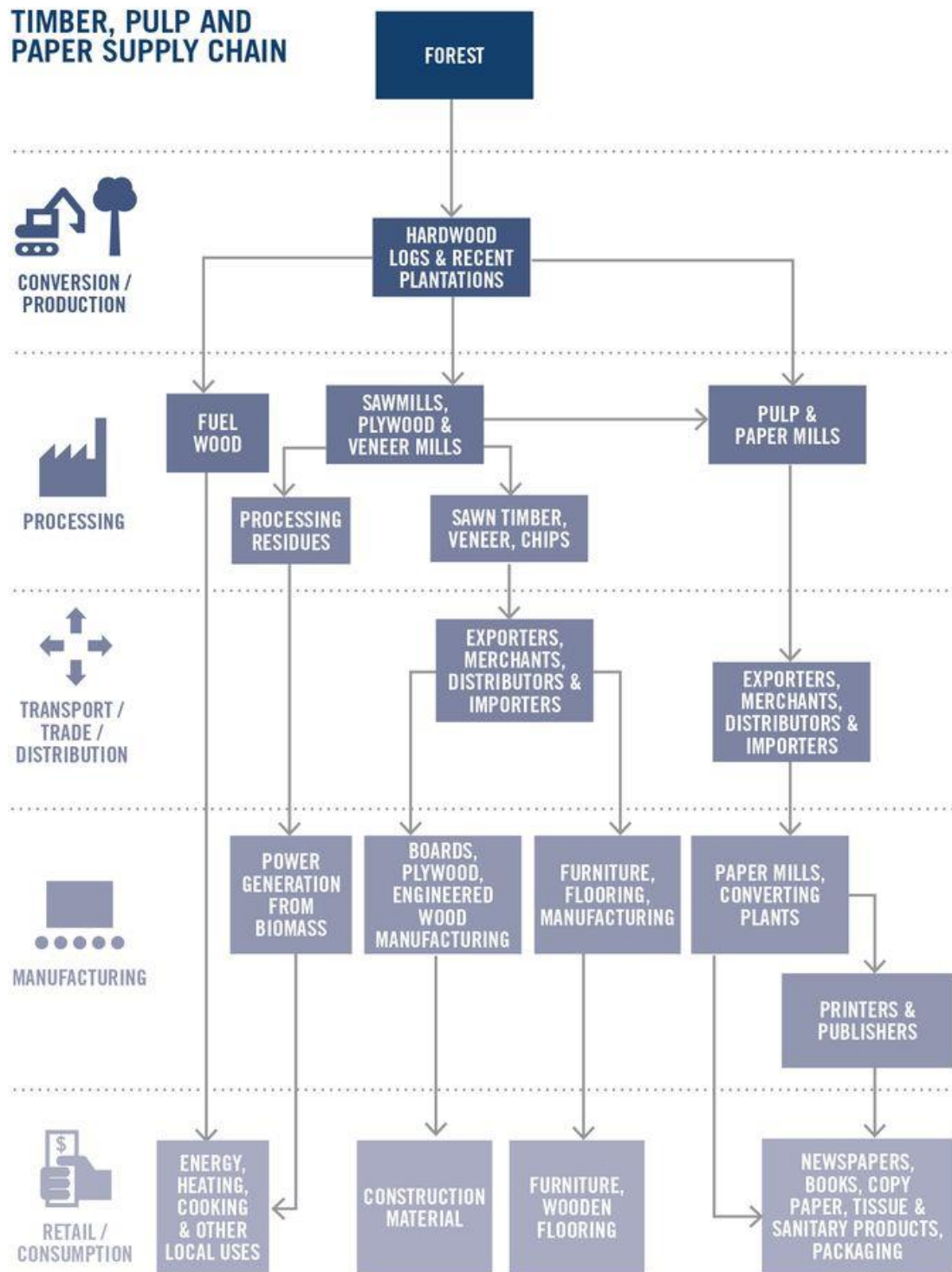
