



Paving the way to sustainability with the Singapore Green Label

Singapore, 14 April 2016 – The Singapore Environment Council (SEC) and Consumers Association of Singapore (CASE) applaud the step taken by the Government to only procure printing paper products certified with the Singapore Green Label, as a move in the right direction towards sustainability.

This was following the announcement made by the Ministry of the Environment and Water Resources during the Committee of Supply debate, with the policy coming into effect from the third quarter of 2016.

Ms Isabella Loh, Chairman of the SEC said, “The Government holds a major stake in Singapore’s green procurement market. SEC is very encouraged that they are taking the lead in green procurement, this says a lot about their commitment to encourage and ensure that the public sector undertake sustainable practices. Having said that, the rest of our consumers, individuals and corporations alike, need to play their part too. I urge private sector, businesses and individuals to take their own responsible green procurement especially printing paper and related products. The collective efforts adds up.”

“We hope that businesses as well as consumers will follow the example set by the Government to take a firm stand and only buy paper products that are procured from sustainable sources. We will need to work together to ensure that Singapore’s voice is heard so that the reoccurrence of the transboundary haze pollution year after year can be resolved,” said Mr Lim Biow Chuan, President of CASE.

SEC encourages other companies which wish to participate in the Singapore Green Labelling Scheme for printing paper products to contact SEC soonest for certification that their products are from sustainable sources.

The Singapore Green Labelling Scheme (SGLS) is administered by the Singapore Environment Council (SEC) and is one of the region's largest and most established environmental certification labels. The SGLS was introduced in 1992 to drive environmental consciousness and responsibility by allowing consumers to choose products meeting eco-standards that are assessed to be "environmentally friendly". With a suite of 50 product categories from paint & surface coatings, office furniture & flooring, to household appliances and personal care products, SGLS has certified more than 3,000 unique products across 27 countries.

SEC's membership in the Global Ecolabelling Network (GEN) – which consist of 25 other member countries from various parts of the world – enables SGLS-endorsed products to be more recognised and accepted outside of Singapore by GEN member countries in Southeast Asia, North Asia, North America and Europe.
